Two (2) seats are available for a term of two years. The deadline to file is Tuesday, April 9, 2024, at 4:30 p.m. You can pick up a Candidacy Form at the Town Office or print one from the website.

Qualifications to file for Council are: Any person at least 21 years of age, who, for a period of at least 15 years immediately preceding his/her election has not been convicted of a felony as that crime is designated by the State of Delaware, and who is a bona fide domiciliary of the Town shall be eligible to hold the office of Council member.

Absentee ballots may be picked up at the Town Office no later than 12:00 noon of the day prior to the election. All ballots must be returned no later than the hour of closing of the polls on said municipal Election Day.
