<b>CANDIDATE COMMITTEE (General Election)</b> (Incumbent by General Election)	<b>INCUMBENT:</b> Candidate in office seeking re-election to the same office.	<b>BEGIN:</b> January 1, immediately following the election when candidate was elected. <b>END:</b> December 31, following the general election in which candidate seeks re-election.	<b>BEGIN:</b> The day after the last reporting period. <b>REPORT:</b> December 31, of every year before or after any election; <b>REPORT:</b> 30 days and 8 days before any election.*
<b>CANDIDATE COMMITTEE (General Election)</b> (Incumbent by Succession, Appointment, etc.)	<b>INCUMBENT:</b> Candidate in office seeking re-election to the same office.	<b>BEGIN:</b> The day candidate attained the office by succession, appointment, or otherwise. <b>END:</b> December 31, following the general election in which candidate seeks re-election.	<b>BEGIN:</b> The day after the last reporting period. <b>REPORT:</b> December 31, of every year before or after any election. <b>REPORT:</b> 20 days and 8 days before any election.*
<b>CANDIDATE COMMITTEE (General Election)</b> (Seeking Election to Office Candidate Does Not Hold.)	<b>CANDIDATE:</b> Candidate seeking office the candidate does not hold.	<b>BEGIN:</b> The day candidate first receives a contribution or makes an expenditure. <b>END:</b> December 31, following the general election in which candidate seeks re-election.	<b>BEGIN:</b> The day the first contribution is received or the day the first expenditure is made . <b>REPORT:</b> December 31, of every year before or after any election. <b>REPORT:</b> 30 days and 8 days before any election.*
<b>CANDIDATE COMMITTEE (Primary Election)</b> (Seeking Candidacy through Primary Election)	<b>CANDIDATE:</b> Seeking primary nomination for candidacy in a general election.	<b>BEGIN:</b> The day candidate first receives a contribution or makes an expenditure. <b>END:</b> The day of the Primary Election.	<b>BEGIN:</b> The day the first contribution is received or the day the first expenditure is made on behalf of the committee. <b>REPORT:</b> December 31, of every year before or after any election. <b>REPORT:</b> 30 days and 8 days before the Primary.*
<b>CANDIDATE COMMITTEE (Primary Election)</b> (Winner of Primary Nomination for Office)	<b>CANDIDATE:</b> Seeking election to office through general election.	<b>BEGIN:</b> The day after the Primary Election. <b>END:</b> December 31, immediately following the General Election.	<b>BEGIN:</b> The day after the last report. <b>REPORT:</b> December 31, of every before or after any election. <b>REPORT:</b> 30 days and 8 days before any election;*
<b>CANDIDATE COMMITTEE (Non-Qualified)</b>	<b>PERSON:</b> Does not hold office nor has taken action to qualify for nomination or election to office.	<b>BEGIN:</b> The day candidate first receives a contribution or makes an expenditure. <b>END:</b> The fourth December 31th following the beginning date. If candidate qualifies for nomination or election, the election period is the same as any candidate seeking an office not held.	<b>BEGIN:</b> The day the candidate first receives a contribution or makes an expenditure. <b>REPORT:</b> December 31, of every year before or after any election. <b>REPORT:</b> 30 days and 8 days before any election;*
<b>POLITICAL PARTY</b>	<b>ORGANIZATION:</b> Eligible to be listed on the general election ballot including all constituent parts.	<b>BEGIN:</b> January 1, immediately following a general election. <b>END:</b> December 31, following the next general election.	<b>BEGIN:</b> The day after the last report. <b>REPORT:</b> December 31, of every year before or after any election. <b>REPORT:</b> 30 days and 8 days before any election;*
<b>POLITICAL ACTION COMMITTEE</b>	<b>POLITICAL COMMITTEE:</b> Which is neither a political party or a candidate committee.	<b>BEGIN:</b> January 1, immediately following a general election. <b>END:</b> December 31, following the next general election.	<b>BEGIN:</b> The day after the last report. <b>REPORT:</b> December 31, of every year before or after any election. <b>REPORT:</b> 30 days and 8 days before any election;*
<b>INDEPENDENT EXPENDITURES</b>	<b>PERSON:</b> Who makes contributions and expenditures, for or against a candidate/s, not in consultation or at the request of any candidate or committee.	<b>BEGIN:</b> January 1, immediately following a general election. <b>END:</b> December 31, following the next general election.	<b>BEGIN &amp; REPORT:</b> Within 24 hours of the contribution aggregating more than \$100 to a single candidate. <b>REPORT:</b> Same as candidate who was supported or opposed.
