Minutes

Audit of Sussex County Primary Election Voting Machines- Round 1, 2, and 3

The meeting was called to order by Kenneth McDowell at 10:00 a.m. on March 29, 2021. Bill Weller was attending the meeting virtually due to Covid-19 concerns. Mr. McDowell gave a brief overview regarding what each round of the audit would entail. Mr. Weller and staff had no questions, so the Audits commenced.

All Election Districts and machine numbers for each audit were randomly selected by Commissioner Albence at a prior date. Staff immediately paired up and began the audit at 10:15 a.m. The first round of audits consisted of a manual recount of Blades Elementary School for the votes cast on machine SC1200. All votes were the same as reported (tally sheets attached).

Round 2 of the audits began at the same time. It consisted of a manual recount of Election District 36-06 from Ellendale Fire Hall. There were four machines SC1215, SC1216, SC1217 and SC1038. All counts came back same as reported (tally sheets attached).

Round 3 of the audits began the same time as the other two and consisted a recount of all votes cast for the Office of Insurance Commissioner at the Lulu Ross polling location. There were three machines including SC1245, SC1246, and SC1247. All votes were the same as reported.

Kenneth McDowell verified the results and took public comments. There were no comments or discussion. Mr. McDowell thanked Mr. Weller for his attendance and adjourned at 11:30 a.m.
