Any qualified elector, duly registered, may cast their vote by **ABSENTEE BALLOT** if they are unable to go to their regular polling place during the forthcoming election for any of the following reasons:

- □ In the public service of the U.S. or of this State, or a citizen of the U.S. temporarily residing outside the territorial limits of the U.S. and the District of Columbia, or such person's spouse or dependent when residing with or accompanying the person, or absent from this State because of illness or injury received while serving in the armed forces of the U.S.; or
- ☐ In the armed forces of the U.S. or the Merchant Marines of the U.S., or attached to and serving with the armed forces of the U.S. in the American Red Cross or United Service Organizations; or
- Because of the nature of such person's business or occupation (This includes persons providing care to a parent, spouse or child who is living at home and requires constant care; students; and otherwise eligible persons who are incarcerated); or
- □ Sick or physically disabled; or
- □ Absent from the municipality while on vacation; or
- □ Unable to vote at a certain time or on a certain day due to the tenets or teachings of that person's religion.

In accordance with Governor Carney's Sixth Modification to the Omnibus State of Emergency, the qualification of "sick or physically disabled" as used in 15 Del. C. §§ 5502(4) and 7571 shall apply to and include any such duly qualified voter who is asymptomatic of COVID-19 infection and/or wishes to self-quarantine or exercise social distancing to avoid potential exposure to (and community spread of) COVID-19, and who herself or himself freely chooses to use such qualification to vote by absentee ballot.
