Automatic Voter Registration (AVR) Implementation


- AVR Implemented: week of 6/19/2023
 - Proceeding well at all DMV locations
- In place for eligible transactions at DMV offices/self-service DMV kiosks/via the mvDMV site
- Information on eligible, unregistered individuals are passed to the Department of Elections for processing
 - Registrations are completed by Elections and registrant receives AVR letter
 - Letter provides option for voter to update information/choose party/cancel registration
- AVR voters may affiliate with a party through date of the first Primary Election following their registration via AVR


