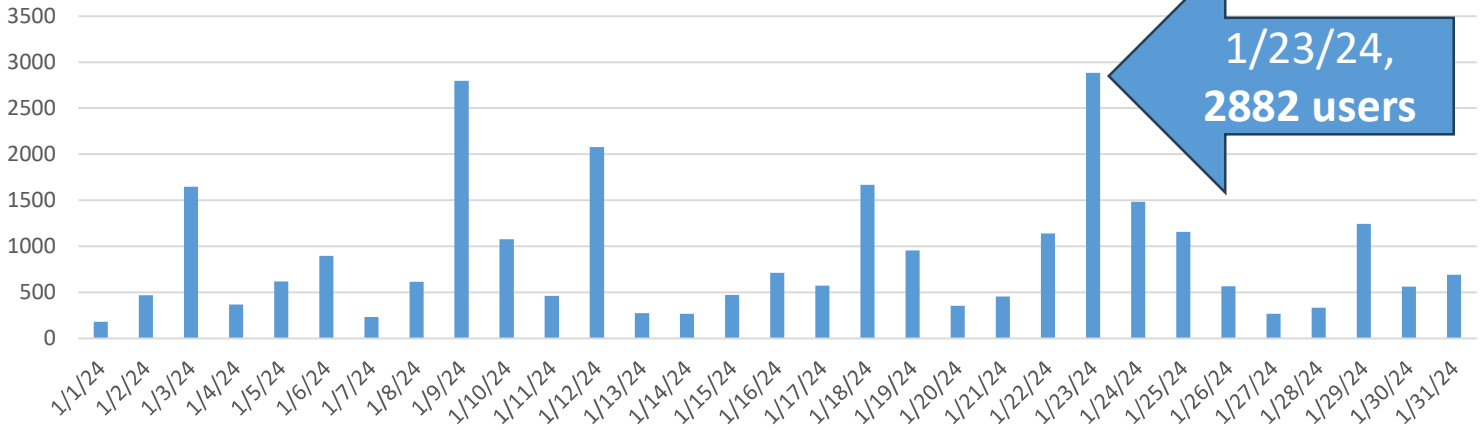

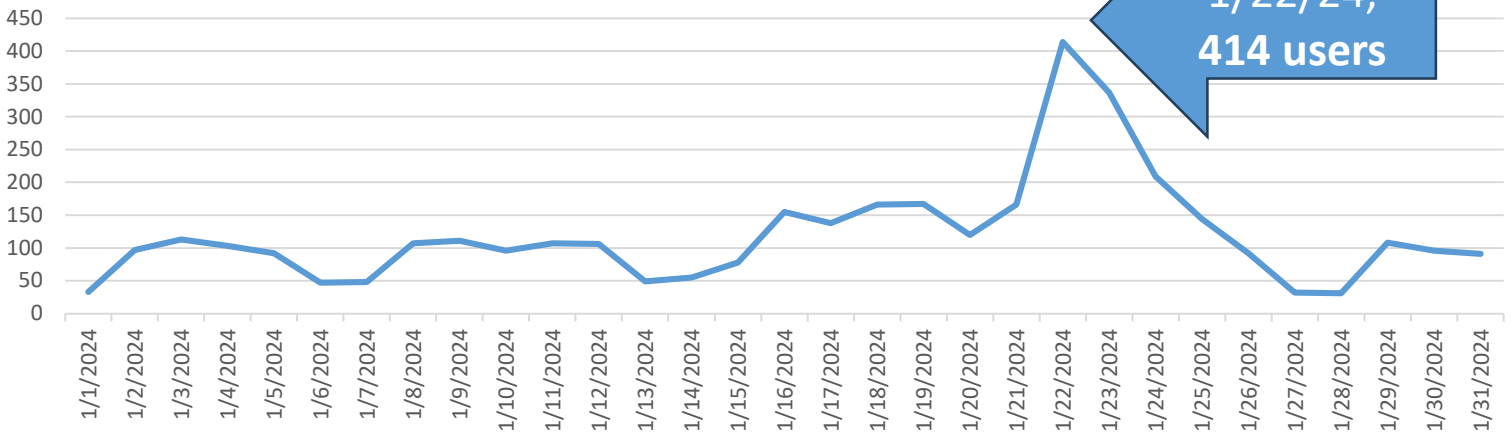
Department of Elections Website Users Per Day
