Re: Committee to Elect Paradee

Dear

In response to your complaint regarding contributions to the Committee to Elect Paradee ("Paradee Committee"), I have reviewed the records of the Delaware Campaign Finance Reporting System and learned as follows. C-11 is a political committee formed on September 12, 2018. It is organized as a political committee, not a political action committee as you state in your complaint. See attached Statement of Organization. It is affiliated with the Democratic Party. These two checkboxes inform the outcome of your complaint.

Let me direct your attention to 15 Del. C. § 8002(19) and (20), which read:

- (19) "Political committee" means:
 - a. Any organization or association, whether permanent or created for the purposes of
 - a specific political campaign, which accepts contributions from or makes expenditures to any candidate, candidate committee or political party in an aggregate amount in excess of \$500 during an election period, not including independent expenditures; and
 - b. All political parties and candidate committees. (emphasis added)
- (20) "Political party" means an organization eligible to be listed on any general election ballot under § 3001 of this title, or any other organization which desires to be

listed on any ballot on any election, and any constituent part of such party which receives contributions and makes expenditures. For purposes of the contribution limits of subchapter II of this chapter, a "political party" includes all constituent parts of such party, including the statewide, county, regional, municipal and district committees, all finance committees and all other committees, subdivisions and organizations related to the political party. (emphasis added)

Read together, for purposes of this analysis, these provisions define a political party as all committees related to the Democratic Party. One type of political committee is a political party. By organizing itself a political committee, C-11 is permitted to contribute the same amount that a political party may contribute under 15 *Del. C.* § 8010(b). The \$2000 contribution by C-11 to the Paradee Committee does not itself exceed the contribution limit imposed by 15 *Del. C.* §8010(b)(6).

You complain as well of what you characterize as a straw-man contribution. Senate D PAC, which is a political action committee, contributed \$600 to the Paradee Committee, which is the limit imposed by 15 *Del. C.* § 8010(a). Senate D PAC also contributed \$5000 to C-11, which enabled C-11 to contribute \$2000 to the Paradee Committee. You believe that these transactions allowed C-11 to improperly circumvent contribution limits using a fictitious name. I do not agree.

Fifteen *Del. C.* § 8011 limits contributions to political parties to \$20,000 per each election period. The contribution from Senate D PAC to C-11, a political party, did not exceed this limit. Moreover, Senate D PAC did not use a fictitious name when it contributed \$5000 to C-11 and \$600 to the Paradee Committee. Each of these contributions were made in the name of the contributor. Each were fully disclosed on the filings made with the State Election Commissioner. Based on the facts that you allege, all of the contributions and expenditures at issue comply with the provisions of 15 *Del. C.* Ch. 80.

I trust I have addressed all of the issues raised in your October 29, 2018 complaint. I thank you for your inquiry.

The total contribution amount from all of the constituent parts of the Democratic Party to the Paradee Committee may not exceed \$5000. You do not allege that the Democratic Party exceeded this limit. In light of your complaint, however, I have researched the records of the Delaware Campaign Finance Reporting System and determined that the total amount of contributions by the Democratic Party to the Paradee Committee did not exceed the statutory limit of \$5000 imposed by 15 *Del. C.* § 8010(b)(6).
