

## Audit of Appoquinimink School District Referendum

On April 25, 2024 at 11:03AM County Director Tracey Dixon called the meeting to order. The following additional persons were present at the meeting: Deputy County Director David Gilefski, Anthony Williams, Graeme Mayberrie, Ron Grovola, and Chauntie-Marie Brown. There were no members of the public present.

The machine and polling places for Phases 1 and 2 were randomly selected. For Phase 1, Graeme Mayberrie selected XL Voting Machine # NCC-0702 which was used at Middletown High School and selected Silver Lake Elementary School as the polling place. Machine numbers NCC-0709, NCC-0710, and NCC-0711 were used at Silver Lake Elementary School. For Phase 2, Ron Grovola selected Brick Mill Elementary School as the polling place. Machine numbers NCC-0675, and NCC-0676 were used at Brick Mill Elementary School.

David Gilefski, Ron Grovola, Graeme Mayberrie, Anthony Williams, and Chauntie-Marie Brown manually recounted the ballots to ensure that the number of ballots processed matched the number of ballots that were present in the secure card containers.
