Election Information

At-Large (2 Seats) 4-Year Terms Ending June 30, 2030

Voting Requirements

- You must be a citizen of the United States and the State of Delaware.
- You must be 18 years of age or older by the date of the School Board Election, Tuesday, May 12, 2026.
- You must be a resident of the School District.
- You DO NOT have to be a registered voter.

PROOF OF IDENTIFICATION AND ADDRESS: Persons appearing to vote must present satisfactory proof of identity and address to the Election Officers at the Polling Place. Persons who do not present satisfactory proof of identity and address, may, upon majority vote of the Inspector and the two Judges, be permitted to vote.

Voting by Absentee if you are eligible

- You may vote by absentee ballot if you are unable to appear at a polling place on Election Day for a reason permitted by State law.
- You must submit to the Kent County Department of Elections office a completed **Request for Absentee Ballot – Public School Elections** by Noon on Friday May 8, 2026, to mail a ballot. You may obtain the **Request** from <https://ivote.de.gov>, <https://de.gov/schabsapp>, by email to votekc@delaware.gov, or by phone at 302-739-4498.
- You may vote in person in our office from 8:00 a.m. – 4:30 p.m. Monday through Friday and until Noon on Monday, May 11, 2026.
- Your voted absentee ballot must be returned to the Kent County Department of Elections office by 8PM on Tuesday, May 12, 2026. Absentee Ballots cannot be returned to Polling Places.
