Audit of Voting Machines used in the 2024 School Board Election for Appoquinimink, Colonial, and Red Clay Consolidated School Districts

Director Tracey Dixon called the meeting to order at 10:00 a.m. on May 16, 2024, in the New Castle County Warehouse.

Others present were Deputy Director David Gilefski, Nyasia Arguilles, and Graeme Mayberrie. There were no members of the public present.

A random selection of the Expressvote XL machines and Polling Places was conducted.

For Appoquinimink School District, machine number NCC-0046, which was used at Old State Elementary School, and polling place Loss Elementary School (machine numbers NCC-0036, NCC-0037 & NCC-0038) were selected for Phase 1. Polling place Bunker Hill Elementary School (machine numbers NCC-0028, NCC-0029 & NCC-0030) was selected for Phase 2.

For Colonial School District, machine number NCC-0094, which was used at Kingswood Community Center, machine number NCC-0110, which was used at William Penn High School and polling place McCullough Middle School (machine numbers NCC-0096, NCC-0097 & NCC-0098) were selected for Phase 1. Polling place Kingswood Community Center (machine number NCC-0095) and Southern Elementary School (machine numbers NCC-0102, NCC-0103 & NCC-0104) were selected for Phase 2.

For Red Clay Consolidated School District, machine number NCC-0143, which was used at Warner Elementary School, machine number NCC-0135, which was used at Marbrook Elementary School, polling place Cab Calloway School of Arts (machine numbers NCC-0120, NCC-0121, & NCC-0122), and polling place Activity Center at Hockessin PAL (machine numbers NCC-0111, NCC-0112 & NCC-0113) were selected for Phase 1. Polling place Joseph Johnson School (machine numbers NCC-0130, NCC-0131 & NCC-0132) and McKean High School (machine numbers NCC-0137, NCC-0137 & NCC-0138) were selected for Phase 2.

For Appoquinimink School District, the ballots cast on all the machines selected for Phase 1 and Phase 2 were hand counted and the results were the same as reported on the voting machine results tape.

For Colonial School District, the ballots cast on all the machines selected for Phase 1 and Phase 2 were hand counted and the results were the same as reported on the voting machine results tape.
