



IMPORTANT NOTICE

**PURSUANT TO DELAWARE LAW
(11 Del. C. Chapter 5, Section 1457B)**

**POSSESSION OF A FIREARM
AT A POLLING PLACE IS PROHIBITED**



POLLING PLACES ARE THE FOLLOWING LOCATIONS:

- A LOCATION DESIGNATED BY THE DEPARTMENT OF ELECTIONS FOR IN-PERSON EARLY VOTING OR IN-PERSON VOTING ON AN ELECTION DAY.
- A LOCATION DESIGNATED BY A MUNICIPALITY FOR IN-PERSON VOTING ON AN ELECTION DAY.
- A LOCATION DESIGNATED BY THE DEPARTMENT OF ELECTIONS FOR THE TABULATION AND COUNTING OF VOTES.
- DEPARTMENT OF ELECTIONS' OFFICE LOCATIONS WHERE SEALED ABSENTEE BALLOT ENVELOPES ARE RETURNED.

FIREARM PROHIBITION AT A POLLING PLACE ON AN ELECTION DAY INCLUDES 2 HOURS BEFORE THE POLLS OPEN UNTIL 2 HOURS AFTER THE POLLS CLOSE:

- FIRST 5 DAYS OF EARLY VOTING, FIREARMS PROHIBITED 9:00AM – 9:00PM
- LAST 5 DAYS OF EARLY VOTING, FIREARMS PROHIBITED 5:00AM – 9:00PM
- ON PRIMARY/GENERAL/SPECIAL/SCHOOL BOARD & REFERENDUM ELECTION DAYS, FIREARMS PROHIBITED 5:00AM – 10:00PM

PERMITTED EXCEPTIONS:

- **LAW ENFORCEMENT OFFICERS, INCLUDING POLICE OFFICERS.**
- **COMMISSIONED SECURITY GUARDS OR CONSTABLES ACTING IN THEIR OFFICIAL CAPACITY AT A POLLING PLACE ON ELECTION DAY.**
- **ACTIVE-DUTY MEMBERS OF THE UNITED STATES ARMED FORCES AND DELAWARE NATIONAL GUARD ACTING IN THEIR OFFICIAL CAPACITY AT A POLLING PLACE ON ELECTION DAY.**

POSSESSION OF A FIREARM AT A POLLING PLACE IS A CLASS A MISDEMEANOR. IF CONVICTED, THE SENTENCE MAY INCLUDE UP TO 1 YEAR INCARCERATION, AND SUCH FINE UP TO \$2,300, RESTITUTION AND OTHER CONDITIONS AS THE COURT DEEMS APPROPRIATE.
