I am the Deputy Attorney General assigned to Delaware's Department of Elections. I am in the process of reviewing the account creation form that you forwarded for the JEFS system to assess the ability of the Department of Election to enter into the agreement.

In the interim, can you please let us know whether the DOJ considers the DE voter registration list, in the form we propose for production, to be subject to the Federal Privacy Act of 1974? Kindly be specific in your analysis if it is your position that the DE voter registration list is not subject to the Privacy Act. And if you believe that it is subject to the Privacy Act, please describe how the DOJ will store and maintain the information consistent with the Act. Please also provide the citation within the Federal Register to the system of records under which DOJ intends to collect and maintain the records it has requested from Delaware.
